FROM YOUR EDITOR



A look at Traditions 10, 11, 12

Tradition 10 - Alcoholics Anonymous has no opinion on outside issues; hence the AA name ought never be drawn into public controversy.

- 1. Do I ever give the impression at a treatment center or other facility that AA has opinions on treatment methods?
- 2. Can I share my own personal experience honestly without stating that it is the AA opinion?

Tradition 11 - Our public relations policy is based on attraction rather than promotion; we need always maintain personal anonymity at the level of press, radio and films.

- 1. Do I promote AA so fanatically at times that I make sobriety unattractive?
- 2. Do I show through my own sobriety that life sober is attractive to a newcomer?

Tradition 12 - Anonymity is the spiritual foundation of all our traditions; ever reminding us to place principles before personalities.

- 1. Do I understand that by practicing the principle of anonymity I am placing the whole of AA's welfare ahead of my own?
- 2. Can I see the spiritual connection to giving of myself in service to God and others?
- **3.** Do I try to get my home group to conform to my standards other than the groups own?

A PIGEON OR A SPONSEE?

I was raised in AA being called a pigeon when I was new, not to mention some other choice names! Some bothered me, some didn't. I never really paid much attention to being called a pigeon, it was what it was. I went to our Area Convention at just under a year sober and thought I was at some sort of presidential affair. All the people there amazed me, hundreds of them. I saw this man standing at a table. People were in line to greet him. He must have surely been someone very important I thought. I waited with my gruff old sponsor. He was seasoned in AA service. I walked up when it was my turn. This man was the area delegate and he asked about me saying, "and who is this Rod" to my sponsor. But before I could introduce myself, my sponsor said" a guy with an ego that's going to kill him." I was introduced that way throughout the entire convention. I didn't like it, but in hindsight I see where it was so true. It sounded much worse than pigeon! He often introduced me as his latest "pigeon". I heard tales about how we were called that because like the pigeons I remember as a child, they were housed, fed and let to spread their wings never really doing much for the ones providing the care.

As times changed, people and our friends started to evolve to the term "sponsee". I still to this day believe the term was an offshoot from the treatment scene, but who knows right? Today everything and everyone seems so overly sensitive, but that is a story for another day! Now to me, that term made me nauseous, sponsee I mean. It sounded sort of cuddling, not at all what I was used to. I continued to use the term "pigeon" and to be honest never really had any of my pigeons confront me about it. It seemed to raise some eyebrows at meetings when I would share or even speak and use the term. Sometimes people would snicker or roll their eyes, chuckle or get riled, there always was a collage of reactions. It seemed to me that anyone who protested the term, wasn't a pigeon in the first place!

So one day recently I thought, "why not look into our history and see if I can find out where the term came from and when it came to be. Like much of our history, there are a ton of takes on every topic, this one is no different. I'll share a few that I found. There's tales of Dr. Bob using it to describe newcomers to be much like the carrier pigeons of World War II who took messages off to their destinations, messages maybe of hope? When they sponsored their "pigeons" it's said they compared them to "pigeons" flying on their way and spreading messages of hope to others. Carrying the message of freedom through sobriety to the suffering alcoholic I've read other stories of sponsors not being "official" until they got their "feather", meaning they their first success with a pigeon. I found this article in an old Grapevine online and the AA Grapevine has given us permission to re-print it in its entirety. Flip the page and enjoy it, see if being called a pigeon sounds so bad after all.

Pigeons

I NEVER CARED for the term "pigeon," as some AA members label a newcomer. Pigeons, to me, always seemed rather ugly, stupid birds. I also related "pigeon" with someone who could be easily conned, and I silently resented the comparison.

After eight months in the program, however, I can glance back over my shoulder at the rocky path I've traveled, and smile a little as I imagine how I must have looked and sounded when I first came in. Very much like a pigeon, I had my beak--nose, that is--to the ground, awkwardly running hither and thither, pecking the dust, trying to find some kernel of sense, some seed of wisdom to explain why I was so miserable, why my life had become unbearable, why I was alcoholic--all the while frantically cooing, "Poor me! Poor me!"

When I finally got my nose out of the dust and looked up, there were the smiling faces of AA members, each holding bags of knowledge of varying size. They gave me bits of their experiences a little at a time. Some, I could relate to and ate hungrily. Others, I couldn't, but these were picked up by my fellow pigeons.

After two months, I was feeling so great, I wanted to remake AA. Why were they hiding all this great joy under a bushel? They should go on nationwide TV so more people could be helped sooner. If I'd had my way, I would have erected a shining white monument to AA in the center of every town from coast to coast--a veritable pigeon's paradise. Only after I had heard many leads, talked to a lot of old-timers, and heard the Traditions over and over, did the words "attraction rather than promotion" really make any sense.

My short time in the program has been sprinkled with some happiness and some disappointments, but my biggest reward is finding a God I can understand, a Higher Power I can talk to on a one-to-one basis, feeling that He is near, gently guiding me. Trouble is, He won't let me do it my way. Every time I take flight in the wrong direction, He pulls a tail-feather or two and quickly brings me back to reality--sometimes with a painful bump.

Despite the admission that "we are not saints," I was convinced that all the people in AA were the closest thing to it-all, that is, except one man, and he nearly put an end to my sobriety. He was a loud, obnoxious, and incessant talker. No one could carry on a conversation when he was around. You couldn't get a word in edgewise. Several times, he brought a tipsy buddy from a nearby bar, who invariably interrupted the meeting. It got so I would avoid my usual round of meetings, because wherever I went, there he was. Later, when I heard he had been hospitalized, I honestly sighed with relief. I couldn't help but wonder what purpose this man had in God's plan.

I recently joined a Step group, and when I came in for the second meeting, there sat the man I had so tried to avoid. As the meeting began and they read, "Came to believe that a Power greater than ourselves could restore us to sanity," I silently prayed that He would protect my sanity. As the meeting progressed and we went around the room, each commenting on what this Step meant to him or to her, I was aware of a feeling of tranquility, as if a Higher Power had joined our group.

When the man I had resented started speaking, I was amazed. Rather than repeating the harsh, sometimes incoherent ramblings I had come to expect, he spoke quietly and simply about his illness, telling how he had struggled, with the help of God and AA, toward the sanity we all speak of so often, but never fully understand. And suddenly, I knew what God's plan had been, for me at least. I hope I never forget that part of the Twelfth Tradition "ever reminding us to place principles before personalities."

This pigeon still has a lot to learn, but this incident and others have made me realize that AA members are *not* all saints; we are a big cross section of humanity with all the courage and the faults of any group. I think the thing that makes us "special" is the love and understanding that surface from our collective consciences. When one member grows weary, there are a dozen others to step in, and the overall effect is that of endless continuity.

The other day, I glanced up and saw a flock of my feathered counterparts winging their way across the blue sky, alternating light and dark as they made their banks and turns in unison. They didn't seem so ugly to me anymore.

V APPENDIX G:

THIRD LEGACY PROCEDURE

PURPOSE


A.A.'s Third Legacy Procedure is a special type of electoral procedure, used primarily for the election of delegates and regional and at-large trustees. It is considered to be unique to A.A., and at first glance, appears to introduce a strong element of chance into a matter that should depend solely on the judgment of the majority. In practice, however, it has proved highly successful in eliminating the influence of factions or parties that seem to thrive on most political scenes. The railroading of a candidate for election is made difficult, if not impossible, since voters have a wide selection of candidates to choose from. More importantly, a second-place candidate who may be extremely well qualified but without early popular support is encouraged to stay in the balloting rather than withdraw.

PROCEDURE

- The names of eligible candidates are posted on a board. All voting members (of the area or Conference body) cast written ballots, one choice to a ballot. The tally for each candidate is posted on the board.
- · The first candidate to receive two-thirds of the total vote is elected.
- 2. Withdrawals start after the second ballot. If any candidate has less than one-fifth of the total vote, his or her name is automatically withdrawn—except that the top two candidates must remain. (In case of ties for second place, the top candidate and all tied runners-up remain as candidates.)
- **3.** After the third ballot, candidates with less than one-third of the total vote will be withdrawn automatically, except the two top candidates remain. (In case there are ties for second place, the top candidate and all tied runners-up remain as candidates.)
- **4.** After the fourth ballot, if no candidate has two-thirds of the total vote, the candidate with the smallest total is automatically withdrawn, except that the top two candidates remain. In case there are ties for second place, the top candidate and all tied second-place candidates remain.
- At this point, the chairperson asks for a motion, second, and a simple majority of hands on conducting a fifth and final ballot.
- If this motion is defeated, balloting is over and the choice is made by lot—"going to the hat"—immediately.
- · If the motion carries, a fifth and final ballot is conducted.
- **5.** If after the fifth ballot no election occurs, the chairperson announces that the choice will be made by lot (from the hat). At this point, the top two candidates remain. In case there are ties for first place, all tied first place candidates remain. In case there are no ties for first place, the top candidate and any tied second-place candidates remain.
- Lots are then drawn by the teller, and the first one "out of the hat" is the delegate (or trustee or other officer).

Once I opened my mouth to the group members about wanting some type of service commitment, I was put in charge of chairing the meeting and finding the speakers for that following month. WOAH, WTH just happened! I silently thought to myself, "don't they know who I am". That's a lot of responsibility for a flaky half committed chick. God had other plans!

I continued going through the steps and applying the principles to my daily life. I showed up every week for my new home group and found speakers. That forced me to use all the numbers on my once unused phone lists. I began to see myself and the world differently. It was as if I had been given a pair of heavenly lenses. Fast forward a few months. Most all senior home group members began leaving, moving to different states. I began to panic! I thought to myself, "I don't know how to run a meeting, handle the money, throw celebrations and get literature. I thought to myself, "no one will trust me with the key to the church." How wrong I was. With the help of an amazing "old timer" and another group member, "who is now my husband" and of course God, I learned how to manage the groups money, fill commitments, plan celebrations and I was even given the key to the church. I was given the crash course in AA service and met mentors that played a crucial part in my getting and staying sober. I am sober today, coming up on 4 years and will forever be of service in this amazing program in whatever way God sees fit!
