Intergroup providers meeting lists, Intergroup board does not feel its feasible to hand the booklets out at the rate we did. The intention is plans to charge more for anything over 10 at \$1 apiece. We are concerned but if the IGR forum wants these meeting list we have to come up with an equitable way to cover the cost and distribution. Right now we are touch and go we can cover the costs of another printing and revisit it in the coming months.

Created budget for website is 1200 a year.

Dave: is that \$1200 a year or every 5 years

Shawn: I helped with the budget. Its \$1200 per year and is cheaper when we renew for multiple years the budget includes Mobinity, whose cost fluctuates on usage meaning the number of text blasts and number of participants. I did a deep dive on the usage and this year was about 3x times the usage compared to last year which costs more. Cost per text is \$0.0037 per participant. Not sure if that the industry standard or if there is a free option. IG plans to look into that. As some alternatives to text blasts which are limited to 139 characters, we have the signup sheets where we could send you an email, and emails are free. IG was told by other intergroups that they love our texts blasts. We will investigate the pricing. That is the cost as is, any services added will obviously cost more.
